### IV. Presentation:

- Thanks to our November presenters Annabelle Black with Novant Health who presented on stroke education and Ally Castelloe with ECU Health who presented on the development of their SAM (Stroke Awareness Matters) video and curriculum for educating 3<sup>rd</sup>-5<sup>th</sup> graders. Slides and link to the recording sent.
- In January Barbara Lutz presented on the PATH-s assessment tool which was developed from the theoretical framework, "Improving Stroke Caregiver Readiness." See her slides.
- Barb Lutz shared that the tool itself is an intervention as it cues caregivers to know what to ask of the team, to
  understand the diagnosis, to think about what it will look like when they get home. She explained they have received a
  small business loan from NIH to turn the tool into an app; not being linked to the patient's medical record is a huge
  barrier. To use My Chart, each patient would need to give permission to access it. They're in discussions about
  releasing it to EPIC. Currently you can access the tool for individual use for free here: <a href="https://www.rehabnurse.org/pathtool">www.rehabnurse.org/pathtool</a>
- Barb noted that CHWs and paramedics would need to be well trained and the connection seamless.
